Nomination and Selection Criteria

Categories

Player – Skaters or Goaltenders Builder – Executive level staff or Coach

Nomination Eligibility Criteria

The Dallas Stars Hall of Fame seeks to recognize players and/or staff members who have positively impacted the Dallas Stars franchise in such a way that their contributions cannot be overlooked. The basic criteria for any individual to be considered for nomination includes:

1. Player Category

- a. Any skater who has played a minimum of 300 games with the Club, or
- b. Any goaltender who has played a minimum of 200 games with the Club, or
- c. Any skater or goaltender who has won the Stanley Cup or a major NHL Award during their tenure with the Dallas Stars.
- d. Must demonstrate exceptional attributes in the areas of playing ability, sportsmanship, character and contributions to the Dallas Stars Hockey Club.
- e. Must not have played in a professional or international game during the previous one (1) season prior to election

2. Builder Category

- a. Must have been employed by the Club for a minimum of 10 years, or
- b. Has won the Stanley Cup or a major NHL Award during their tenure with the Dallas Stars.
- c. Must demonstrate exceptional attributes in coaching, managerial or executive ability, or ability in another significant off-ice role, sportsmanship, character and contributions to the Dallas Stars Hockey Club and to the game of hockey in general.
- d. May be active or inactive at the time of his/her election.

3. Annual Maximum Number of Elected Candidates

- a. Players Maximum of One (1)
- b. Builders Maximum of One (1)
- c. There is no requirement that the maximum of either category is reached in any given election period.



4. Retired Numbers

- a. Any player who currently has their number retired by the Dallas Stars Hockey Club receives immediate inclusion into the Dallas Stars Hall of Fame without consideration by the Selection Committee.
- b. Official induction into the Dallas Stars Hall of Fame will occur the year following their jersey retirement ceremony.
- 5. Owners all owners of the Dallas Stars Hockey Club receive automatic induction as Builders without consideration by the Selection Committee.

Nomination Submissions

Written nominations may be submitted to the CEO by all members of the Selection Committee using the provided nomination form from April 1 through May 1 of each calendar year. Written nomination should include main points of influence for all committee members to consider during the nomination process.

Each member may submit the name of One (1) Player and One (1) Builder during each nomination cycle. The nomination process will be blind to the selection committee with the exception of the CEO.

In addition, a Fan Nomination will also be included into the Nomination pool. This will be conducted electronically by the team in advance of the June meeting and included into the entire pool of nominations to be considered by the Selection Committee.

Balloting Procedures

Seven days prior to the annual Selection Committee meeting, each member will receive the complete list of nominations along with the written nomination forms provided by the individual committee members for review.

Order of Balloting Procedures

- 1. At the annual Selection Committee meeting, the Committee will first hold ballot elections in respect to the Player Category, and secondly in respect to the Builder Category.
- 2. Each Committee member will receive a ballot listing all nominations received for each category.
- 3. Each member of the selection committee will then place their vote for One (1) Nominee based upon their careful review of all nominations.
- 4. Each vote is by secret ballot.
- 5. CEO will then count votes and reveal top vote recipient(s) to the Committee. Actual vote tally will not be revealed.

Any nominee who receives 70% of the vote (or 9 votes with a 13-person committee) will receive automatic induction. If no nominee receives 70% of the vote, then following a discussion period, a run-off ballot will be held for the top two nominees who received the most votes. For the run-off vote, a majority win (7 votes) will receive induction.

The same process will be repeated for the Builder category with only one induction allowed per election period.



Proceedings Confidentiality

The names of candidates who are nominated for election as Honoured Members, but who are not elected as such, shall not be disclosed at any time to any person other than representatives of the Dallas Stars Hall of Fame Selection Committee. Similarly, candidates who are nominated for election shall not be advised of their nomination and at no time shall such representatives of the Committee disclose to any person whether any particular eligible candidate has or has not been nominated in any particular year.

No member of the Selection Committee or any other person present at the election meeting shall disclose to any person any comments, opinions or other particulars from the Selection Committee's deliberations concerning any candidate or how any member of the Selection Committee voted on the election of any candidate or any other particulars of the balloting on all candidates.

After the Selection Committee has completed all balloting for election into Honoured Membership, the CEO or his designate will inform the Inductees personally and will then release the names of those elected for general publication.
